Brentwood Recreation Camp Rules

- 1. Brentwood is owned and operated by the Duncan Arizona Stake of the Church of Jesus Christ of Latter-day Saints, therefore all individuals using Brentwood and the facilities must adhere to church standards, i.e. Modest Dress, proper language, Word of Wisdom (No Tobacco, Alcoholic beverages, etc. are allowed or the use of such on Brentwood property.)
- 2. **No Sunday camping. Campers are to vacate camp by Saturday night.** Campers can return on Monday if scheduled.
- 3. The Camp Host is in charge of the camp and will assign campsites and will address all problems and questions. His decisions are final. There is not to be any camping in the meadow.
- 4. Fees There is a \$3.00 per person per day camp fee. This fee is used to offset expenses of maintaining Brentwood facilities, improvements, repairs, fuel and supplies. There is a \$25 non-refundable deposit to hold a reservation; it will apply to the camp fee.
- 5. Brentwood does not provide tents or cooking equipment. We do have two 18x20 foot canopies that can be used.
- 6. Tables and chairs are available for campers to use if they need tables. If campers use tables they need to protect them and keep them out of the rain.
- 7. Water, propane for water heaters, <u>Cleaning Supplies and Toilet Paper</u> are furnished by Brentwood and controlled by the Camp Host.
- 8. Do not tamper with water pump or water heaters or change settings on water heaters.
- 9. Fires are to be made in the designated fireboxes. New fireboxes (made of rocks, etc.) are not to be made. Miscellaneous built fires is a fire danger and will kill the ground where the fire was built.
- 10. Keep Brentwood policy of cooperating with the U.S. Forest Service and adhere to their rules and regulations whenever possible. Example: When the forest is closed to open campfires, Brentwood is closed to open campfires.
- 11. Do not chop, cut into or hammer nails into any standing trees. If rope, etc. is used to lash any camp facilities to trees, be sure to remove rope, especially wire, etc. when breaking camp.
- 12. No motorized vehicles of any kind in the meadow, except authorized maintenance equipment.
- 13. No ATV's in camp except for the following,
 - a. The one or two used by the Camp Host to perform his duties.
 - b. Those identified for use by the handicapped.
 - c. Those campers who have ATV's for traveling to and from destinations away from camp. ATVs are not to be used for running around camp for pleasure. They should always stay on the designated roadways.
- 14. No firearms of any kind and no fireworks of any kind are allowed in camp. Except during Girl's Camp or Aaronic Priesthood camp used as part of the camp curriculum, under the control of adult leadership.
- 15. Remove all traces of your camp when breaking camp.
- 16. Campers are to furnish their own First Aid Kits, toilet and showers supplies (soap, towels, etc.) when using the toilets and showers. "Leave showers clean." Campers are to provide their own cooking and serving equipment, etc.

- 17. Campers are to assure that campfires are out and dead before campers leave camp. Do not leave unattended fires. Do not try to burn non-burnable items or bury trash at Brentwood. Campfire places are to be left with only wood fragments thoroughly extinguished. All other items not burned are to be removed from the campsite with other trash.
- 18. All campers are to keep their trash and garbage in removable containers such as plastic bags, cans, etc. There are no designated camp trash containers. All items brought to Brentwood are to be removed from Brentwood by campers by carrying them back home.
- 19. No trailers are to be left hooked up when not occupied after their designated stay. Trailer sites are to be available for the next scheduling campers. If a trailer is left, it should be left in a designated parking area, assigned by the Camp Host. Note: If a trailer is parked on U.S. Forest Land and left unoccupied, the Forest Service will consider it unoccupied if left unattended for more that 3 Days. After 3 days the Forest Service may remove it.
- 20. Trenching tents should be done sparingly, and put back as it was when finish. Avoid destroying plants.
- 21. No pets allowed, except on a leash at all times. Do not let barking dogs or pets annoy other campers. Clean up all litter from your pets.
- 22. Observe U.S. Forest Service policy of "No Trace Camping" as much as possible.
- 23. Individual families or family reunion groups are not to dominate the shower and toilet facilities and must camp a reasonable distance from them as to allow other families or reunions to use the facilities. This also complies with state health laws of maintaining reasonable distances to such facilities.
- 24. Families or reunion groups are not to use shower and toilet facilities for storage during their stay in camp.
- 25. If a family or group desires a barbecue, they must schedule the Camp Barbecue Pit. There is only one approved barbecue pit for the camp. If U.S. Forest Service has campfire restrictions, then the Camp Barbecue Pit cannot be used.
- 26. Be considerate of other campers and keep noise down, i.e., loud radios, <u>loud generators</u>, etc. Leave main access road clear at all times (park vehicles off main road.)
- 27. The new pavilion enhances the facilities. Do not put cooking stoves on the floor where grease falls on the floor and soaks into the concrete. Cook stoves can be set up near the pavilion. If bad weather exist campers should provide their own canopy for covering cooking equipment.
- 28. Camp sites are to be kept clean, neat and orderly during campers stay. Campers are to clean the shower and toilet rooms before they leave camp, cleaning supplies will be provided. Camp Host will inspect. It is the LDS Church's practice to keep all of its properties in a neat and attractive condition, including its recreational properties.
- 29. In the case of family reunions it is the responsibility of the agent family to ensure that the camp rules are adhered to and camping sites are kept orderly and left in proper condition. Agent family is to make sure all fees are paid and make the final inspection of their area. Each family is to have a designated person (agent, spokesman, etc.) for Camp Host to communicate with.
- 30. Keep Brentwood for the future; leave it better than you found it.
